Discussion	Approved In support of the WDB's Strategic Plan, the Economic Development Agency/Workforce Development Division released a new three-year Request for Proposal (RFP) for Business Process Improvement Services on October 2, 2017, for program years 2018/21. The purpose of the procurement is to reduce Rapid Response Services by helping struggling businesses remain competitive and retaining jobs at those businesses. These Business Process Improvement Services would not be otherwise provided without Rapid Response Funding.							

California Manufacturing Technology Consulting (CMTC) was the only proposal received and they will provide business processing services to the manufacturing industry.
